- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins at or about 12:00 PM Eastern Time (“ET”) on December 20, 2024 and ends at 11:59:59 PM ET on February 10, 2025 (“Sweepstakes Period”). The Sweepstakes Period is comprised of two (2) entry periods (each, an “Entry Period”) as set forth in the chart below:

Non-winning entries submitted in Entry Period 1 **will** carry forward into Entry Period 2. The Administrator’s computer is the Sweepstakes official clock.

- 2. ELIGIBILITY:** This Sweepstakes is offered only to legal United States residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees, directors, officers, and agents of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotional agencies, and suppliers involved in the Sweepstakes (“Sweepstakes Entities”), as well as the members of each of their immediate families (defined as spouse, parents, children, and siblings) and persons residing in the same household (whether related or not) as such individuals are not eligible to enter or win. Void where prohibited or restricted by law.

Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions and interpretations, which are final and binding in all matters related to the Sweepstakes.

- 3. HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, an eligible entrant must log on to <http://tailgatewithauthority.com> (the “Website”) and submit their valid e-mail address. The entrant then must register by entering the information requested on the registration form, which may include without limitation: first and last name (initials are not permitted), complete mailing address (P.O. Boxes are not permitted), date of birth, telephone number and affirmation that the entrant has read and agrees to be bound by these Official Rules. The entrant will then be prompted to vote for their favorite Flavortown Sauce flavor.

Upon completion and submission of the registration form and participation in the poll, the entrant will receive one (1) entry into the Sweepstakes.

Limit: Each entrant is limited to receiving one (1) entry per day during the Sweepstakes Period. If more than one (1) entry per day is received from the same person, telephone number, or e-mail address, only the first entry received may be considered valid. For purposes of this Sweepstakes, a “day” is the twenty-four (24) hour period between 12:00 AM ET and 11:59:59 PM ET, except on December 20, 2024, on which a “day” will be the period between 12:00 PM ET and 11:59:59 PM ET.

NOTE: If you access the Website via a mobile device, message and data rates may apply. Not all mobile telephone providers carry the service necessary to participate in this Sweepstakes. Entrants should consult their wireless provider’s pricing plans.

4. **RANDOM DRAWING:** On or about January 27, 2025, the Administrator will randomly select one (1) potential Grand Prize (as defined in Section 5 below) winner from all eligible entries received during Entry Period 1. On or about February 11, 2025, the Administrator will randomly select three (3) potential First Prize winner, three (3) potential Second Prize winners, ten (10) potential Third Prize winners, and three thousand (3,000) potential Fourth Prize winners, as the capitalized terms are defined in Section 5 below, from all eligible entries received during the Sweepstakes Period. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with the Official Rules.

5. PRIZES, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:

- A. **Grand Prize (1):** The “Grand Prize” is a trip for two (2) people – the Grand Prize winner and one (1) guest – to attend Guy Fieri’s tailgate scheduled to occur on February 9, 2025 in New Orleans, Louisiana (the “Tailgate”). The Grand Prize is awarded as Ten Thousand Dollars (\$10,000) made payable to the Grand Prize winner via PayPal and two (2) VIP tickets to be used by Grand Prize winner and guest to attend the Tailgate. Grand Prize winner is solely responsible for all travel arrangements. Tailgate VIP tickets have no retail value. Only one (1) Grand Prize will be available in the Sweepstakes. The ARV of the Grand Prize is Ten Thousand Dollars (\$10,000).

- B. **First Prizes (3):** Each “First Prize” is a Flavortown Tailgate at Home package, which includes: one Guy Fieri Flavortown Woodwind Pro 36 grill, a 10-piece laser titanium pots and pans set, an Ergo 10” meat slicer and sheath, and a pepper cannon. No more than

three (3) First Prizes will be available in the Sweepstakes. The ARV of each First Prize is \$2,299.97.

C. Second Prizes (3): Each “Second Prize” includes the following items: an air fryer, a vacuum sealer, a pepper cannon, and a 10-piece stainless steel pots and pans set. No more than three (3) Second Prizes will be available in the Sweepstakes. The ARV of each Second Prize is \$579.96.

D. Third Prizes (10): Each “Third Prize” is a Wear Your Flavortown Pride t-shirt (size and style determined by Sponsor). No more than ten (10) Third Prizes will be available in the Sweepstakes. The ARV of each Third Prize is \$39.00.

E. Fourth Prizes (3,000): Each “Fourth Prize” is a free product coupon. No more than three thousand (3,000) Fourth Prizes will be available in the Sweepstakes. The ARV of each Fourth Prize is \$5.00.

F. Total ARV: The total ARV of all available prizes in the Sweepstakes is \$34,029.79.

G. Odds of Winning: The odds of winning the Grand Prize depend on the total number of eligible entries received during Entry Period 1. The odds of winning a prize (other than the Grand Prize) depend on the total number of eligible entries received during the entire Sweepstakes Period.

H. General: All prize sizes and styles determined by Sponsor in its sole discretion. If, for any reason, more prize notifications are sent (or more claims are received) than the number of prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of prizes through a random drawing from among all eligible prize claims received. Limit of one (1) prize per person. THE AAA RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR SWEEPSTAKES ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.
